# The Urgency of Guidance and Counselling in Primary Schools

Unlike the secondary and upper education levels, there are still no guidance and counseling teachers at the elementary school level. Therefore, the class teacher will carry out all forms of guidance and counseling services to anticipate and prevent all problems early so that learning activities run smoothly. - Counselors (guidance and counseling professionals) are not present in elementary schools.
- 2. Inability, time, and resources to develop programs.
- 3. Misconceptions about Counselling and guidance.

- 4. The lack of an easy and practical program development model to guide classroom teachers in developing their elementary school guidance and counseling programs.
- 5. Absence of means for class teachers to implement traditional guidance services that include guidance materials and are equipped with practical, ready-to-use, and simple-to-use presentation media.

Guidance and Counselling essential components of education improving educational quality, particularly in Indonesia. To realize this, it is necessary to have the cooperation of all relevant parties supported by the professionalism educators so that education is not only limited to the transfer of learning materials but also with a concentration on students' affective and psychomotor aspects. Elementary school teachers are also always required to understand and understand the concept of guidance and counselling in schools considering that class teachers are responsible for implementing guidance and counseling services in elementary schools.
