Its success highlights law as social service rather than punishment. To enhance this role, recommendations include capacity building, systematic documentation, stronger collaborative networks, community legal education, and advocacy for supportive regulations, ensuring restorative justice becomes a sustainable and legitimate model.

2.2 *Legal Assistance*

Legal assistance, as described by [9]–[13], refers to services provided by legal aid organizations, lawyers, and paralegals to guarantee access to justice through the protection, education, and defense of citizens' rights, especially for vulnerable groups, in both litigation and non-litigation contexts; this mechanism not only safeguards the principle of due process of law but also functions as legal empowerment, enabling communities to become legally independent, preventing the criminalization of the poor, supporting gender-based violence victims, and bridging the gap between normative law and substantive justice, despite ongoing challenges such as resource limitations, low legal literacy, and institutional constraints.

2.3 *Legal Aid*

Legal aid, as regulated by Law No. 16 of 2011 and analyzed by [9]–[12], [14], is a constitutional instrument that guarantees equal access to justice for the poor through free legal services provided

by legal aid institutions, lawyers, or paralegals; its role extends beyond litigation to include public policy advocacy, community empowerment, and the protection of vulnerable groups such as women and children, thereby promoting substantive justice rooted in human dignity; although constrained by limited funding, uneven service distribution, and political interference, legal aid remains a vital pillar of democracy and human rights in Indonesia, symbolizing the state's commitment to protecting its most disadvantaged citizens.

3. METHODS

The research method employed is a descriptive-analytical approach aimed at systematically illustrating the strategies of Law Office & Associates "Solidaritas" Pemalang in delivering restorative justice to the surrounding community; primary data were obtained through a review of relevant articles, regulations, and theories, while secondary data were collected through participatory observation of legal services focused on restorative dispute resolution, interviews with lawyers, staff, and service recipients to explore strategies, challenges, and achievements in applying restorative justice, as well as documentation studies of case reports, legal education modules, and mediation outcomes to strengthen the findings, with all data analyzed using a qualitative descriptive approach to provide a comprehensive understanding of the implementation of restorative justice strategies and their impact on society.

In a cultural context like Pemalang, where kinship and communal bonds are highly valued, such restorative efforts are especially effective in preventing further social fragmentation.

Despite facing challenges such as limited human resources, heavy caseloads, and the need for sustainable funding, "Solidaritas" addresses these through cross-sector collaboration and partnerships with civil society organizations. This collaborative strategy reinforces effectiveness and ensures consistent application of restorative processes.
